Subject: Prime Minister National Apprenticeship Mela (PMNAM)/ Quarter July to September 2022.

Dear Sir/Madam,

Please refer to letter of even number dated 15.06.2022 on the subject (attached) vide which States/UTs were requested to identify apprenticeship Mela locations for the quarter July-September 2022. The above letter was communicated as an attachment to email dated 16.06.2022.

2) In response, we have received from various States and UTs, the information regarding Apprenticeship Mela Centres for Pradhan Mantri National Apprenticeship Mela (PMNAM) for the month of July 2022, August 2022 and September 2022. (List enclosed). July 2022 edition of PMNAM was conducted as scheduled.

3) It is aware that due to ongoing Craftsmen Training Scheme (CTS) Examination in this Month (August 2022), PMNAM for the month of August 2022 has been deferred. However, PMNAM for the month of September is scheduled as usual on the 2nd Monday i.e. 12.09.2022

5) In view of the above, apprenticeship Mela Centres identified for the month of August 2022 may, therefore, be treated as centres for the month of September 2022 and Mela Centres identified by States for the month of September 2022 may be considered as Mela Centres for the month of October 2022. Accordingly, instructions may be issued to those ITIs / centres for preparing themselves for the PMNAM. If, there any change in the enclosed Mela Centres list, the same may be brought to our notice immediately.

6) Further, States which are yet to identify the Apprenticeship Mela Centres are requested to be identified immediately and send the list immediately latest by 02nd September 2022.
